







During June 2022, the IOF killed 14 Palestinians, distributed as follows:














Home Demolitions


In June 2022, the Israeli occupying authorities demolished 22 homes, including one punitive demolition, geographically distributed as follows:










Demolition of Private Structures


The Israeli occupying authorities demolished 45 privately-owned structures, geographically distributed as follows:












Other Violations¹

In June 2022, Al-Haq documented dozens of other violations committed by the Israeli occupying authorities, most notably:

Location	Date	Violation
Tubas	1 June 2022	Members of the IOF and officers of the Israeli civil administration confiscated a number of Palestinian vehicles in the areas of Farisyya, Al-Burj, Al-Maita and Al-Aqaba.
Beit Lahia- Gaza	4 June 2022	The Israeli navy forcers chased two fishermen brothers who were fishing within the allowed area and opened fire towards them, injuring one of them with a rubber bullet in his leg. They also damaged their boat and arrested them. They were released after a few hours.
Tura Al- Sharqiya- Jenin	5 June 2022	An Israeli female soldier forced a three-year- old Palestinian child to take off his T-shirt because it has a weapon print on it, while he was passing through the annexation wall gate #300 that separates the village of Tura from the village of Um Al-Rihan in Jenin.
Gaza	6 June 2022	The Israeli occupying authorities refused to issue a permit for a sick Palestinian infant that needed medical treatment outside Gaza, especially giving that there were no possibilities for treating her in Gaza's hospitals.
Bourin- Nablus	11 June 2022	Settlers of the Israeli outpost Givat Ronen set fire into hundreds of trees including olive trees in the area of Al-Jheir and Habayel Abu Isma'el in the east of Bourin. Under the protection of the IOF, they also assaulted the Palestinian firefighters who arrived to the location to put the fire out.

Duma- Nablus	16 June 2022	Group of Israeli settlers attacked a Palestinian family in their car near a military checkpoint at the main western entrance of Duma, sprayed pepper gas towards an infant and her mother. This gas caused burns and difficulty in breathing and the attack terrified all of the family members in the car. This attack took place in front of the Israeli soldiers who stood still without doing anything to stop them.
Deir Sharaf- Nablus	20 June 2022	Group of settlers removed Palestinian flags hanged at Deir Sharaf square and attacked Palestinian properties and vehicles that were passing through Nablus- Jenin Street. A child was injured with a stone in his leg.
Jalboun- Jenin	21 June 2022	Under the protection of a military force, members of the construction unit in the Israeli civil administration distributed eight stop-work warrants and an additional demolishing warrant against Palestinian homes in the village of Jalboun under the pretext of not having a construction permit in Area C.
Beit Dajan- Nablus	24 June 2022	The IOF suppressed a protest in Al-Thaghra northern Beit Dajan and wounded a paramedic of the Palestinian Medical Relief Society with a sponge grenade in his left cheek and a stun grenade in his chest.
Al-Sharqi neighborhood- Jenin	27 June 2022	Military dogs accompanying a military force attacked Palestinians whilst in their home and wounded a number of them including a Tawjihi student. They arrested four family members then left the place.

Joint Security Force	7 June 2022	Palestinian security forces arrested a number of activists of "Bedna N'ish" (we want to live) movement while protesting near Abu Rushd Square in the middle of Hebron. They were interrogated regarding their coup attempt, causing chaos and closing the roads. They were brought before the General Prosecution and were accused of organizing illegal protests. After 48 hours, they were released after signing a pledge not to close any roads during any future events/ protests.
Joint Security Force, Security of Al-Najah University and members of Al- Shabiba students' bloc	8 June 2022	Members of a joint security force, the security of Al-Najah University and members of Al- Shabiba students' bloc physically assaulted journalists and students who were participating in a protest in front of the "new campus" in Al-Najah University in the west of Nablus.
Joint Security Force in Gaza and armed civilians	9 June 2022	Members of a joint security force accompanied by armed civilians broke into the Bedouin village located in Beit Lahiya. Moreover, they demolished a Palestinian home claiming that it is built on a state land, which was met with rejection by the population. Thus, the security personnel violently suppressed the protests using live ammunition and arrested tens of people there. This suppression resulted in wounding six Palestinians with live ammunition and its shrapnel, ten others were injured and bruised, two police members were injured in addition to another two paramedics.
Al-Najah University Security members	14 June 2022	Members of security personnel in Al-Najah University beat university students and sprayed their faces with pepper gas whilst participating in a protest in front of the "old campus" of the university in Rafidia in the west of Nablus.

June 2022 Special Focus

Israeli Settler Stabs Palestinian Ali Harb in his Heart to Death, in the Village of Iskaka- Salfit

On Tuesday, 21 June 2022, at around 6:00 am, Israeli settler stabbed to death the Palestinian man Ali Harb, 27, with a knife in his heart in the village of Iskaka near Salfit. In this day and while Ali, his brothers and cousins were sitting in their house yard, his father received a phone call from one of the shepherds informing him that a group of settlers arrived to his own land located in Al-Jabal area next to Ariel Settlement. Settlers were apparently attempting to establish a structure in the place. Ten Palestinian men have arrived to the location and started yelling at the settlers and said "leave, leave, go out of our lands". At this moment, settlers started to step back closer to the fence of Ariel Settlement, while yelling at Palestinians in unclear Hebrew. After a few minutes, an armed settler with a civilian attire arrived to the place with a white Tender car, Palestinian men in the place assumed he was one of the settlement guards. He started speaking in English with Ali who told him that these settlers are working in his family's own lands and they have to leave. The settler responded that the Israeli soldiers will come and take them out. Meanwhile, an Israeli police force arrived to the place, with their weapons drawn, and opened fire in the

air, until they approached the place where Ali and his cousins; Zaid and Amjad, were standing. Zaid describes the killing of Ali as follows:

"Israeli Police and security force approached us; me, Ali and Amjad, while we were standing in our land; Ali was standing to my left side with Amjad to the right. I noticed one of the settlers walking quickly towards us, he was about 90 meters aways then came to ten meters close to us when he started throwing stones. This happened in front of the soldiers who did nothing to stop him from attacking us. While throwing the stones, the settler was yelling at us but we did not understand what he was saying. Then he came closer to us, about three or four meters away, and he was putting his hand on his right side as if he attempted to take something out to scare us. When he came closer to us, about two meters away, he took out a 20 cm-long knife and stabbed Ali with it. When I tried to hold his hand to prevent him from stabbing Ali and to push him back, I was attacked by another settler, who was about two meters away. The settler stabbed Ali with the knife under his left arm, who fell on the ground. Following this stabbing, the settler fled towards the group of settlers but the soldiers did not follow him. This specific settler had a short beard, was wearing an army-green pants and a black shirt that covered the upper part of his pants, putting on a hat (similar to the one that construction workers usually wear) and a black glove in his left hand. He was of average height and build. The Israeli soldiers prevented other Palestinians from helping Ali while he was injured and laying in his blood. Firas Harb, Ali's cousin, reported that "I saw Ali falling on the ground and I tried to help him after Zaid and Anas started shouting 'Ali is stabbed, Ali is stabbed', but one of the soldiers, with civilian attire and a blue shirt, kept pointing his weapon towards my head and shouting on me whenever I attempted to approach Ali. The soldiers did not help him in any way and prevented us from helping him as well. After about ten minutes, Anas and Zaid Harb were able to carry Ali and transfer him near other Palestinians in the place, who carried him hundreds of meters in the mountains while he was a dead body, until they arrived to the main road and the ambulance that took him to Yassir Arafat hospital in Salfit where he was pronounced dead after half an hour of his arrival.

It is worth mentioning that Ali Harb had four brothers and one sister and he is the oldest among them. He graduated from Al-Quds/ Abu Dis University where he obtained his Bachelor's degree in electronic engineering in 2018. Following his graduation, Ali did not find a job in engineering so he worked in constructions for a while, then he worked as machine- maintenance engineer but he left this job about three weeks before the settler killed him.

During the time that followed his graduation, Ali was learning the English language and got many certificates in it as he was looking for a scholarship to do his MA in engineering in Germany. According to his brother's affidavit, Ali was an experienced player of chess and other games that require high mental concentration. About six months ago, he was ranked second in a chess competition at the level of Salfit governorate. Moreover, he has previously obtained several advanced ranks in many local chess competitions. Ali was a big dreamer who wanted to achieve a lot during his lifetime but the settler violence stole all his dreams.
